## **RULES AND REGULATIONS FOR INDIA VOICE FEST AWARDS 2020**

1. SUBMISSION OF ENTRIES FOR THE INDIA VOICE FEST AWARDS 2020 IS **ABSOLUTELY FREE** AND OPEN TO ALL INDIAN INDIVIDUALS.
2. The entries will be judged by a panel of esteemed professionals from the Audio and Visual industry. The decision of the jury will be final. We will not be accepting or admitting any dispute in this context. The jury will **ONLY** be given the Audio/ Video content submitted in the entry and **NO NAMES** will be shared with the Jury.
3. Uploading an **IDENTITY PROOF** in the form of PAN Card Copy or Aadhar Card copy is mandatory at the time of submitting your entry.
4. An individual can submit up to a maximum of 10 entries with a limit of maximum of 2 entries per category/ per language.
5. While submitting the entry for the awards is **FREE**, organizing the **EVENT** is **NOT** 😊 Hence, we request you to **ALSO** book your ticket for the 2020 Online edition of the event on [www.indiavoicfest.com](http://www.indiavoicfest.com)
6. We are accepting entries for work that has been **BROADCAST** between 16th September 2019 and 15<sup>th</sup> September 2020 (both days inclusive). This undertaking is implied to be given by the person submitting the entry and any misinformation would render the entry void and invalid.

7. Please upload the **AUDIO or VIDEO file** of your work in our Nomination form. You can easily DOWNLOAD your work/ convert it into an Audio or Video file using any of the FREE software available online.
8. We are not accepting any GOOGLE DRIVE/ WETRANSFER/ ONEDRIVE link of any work to be submitted for the awards. Please upload the audio or video file only.
9. It is important that each person submitting her or his work for the awards NAME the FILE which is being uploaded/ submitted with the name of the artist along with language and category. This will eliminate any confusion during the final sorting of entries.
10. The categories for India Voice Fest Awards 2020 are mentioned on the website [www.indiavoicfest.com](http://www.indiavoicfest.com) and also in the Google Form required to fill to submit the entries for the awards.
11. While we are excited to receive entries in English and Indian languages, for a category or language to be declared final and eligible for the awards we need to have at least 5 entries in a particular Category and Language. For eg; if we receive 3 entries in a particular language in a category, we will not be able to justify that as a final category for the jury.
12. Here is the minimum duration of work that will be required by our Jury as per each category.
  - a. **TV Commercial/ TV Promo/ Radio Promo** – Full Content or 1 minute whichever is higher.
  - b. **Singing for Dubbed Content/ Audio Book/ Corporate Audio Visual/ Digital Film/ Audio Drama/ TV show** – in episode narration – Full Content or 3 minutes, whichever is Lower.
  - c. **Dubbed Content/ Live/ Animation for any medium** – Minimum 3 minutes. Maximum 5 minutes.
13. The Award presentation will be ONLINE on the last day of the India Voice Fest 2020 event which is a purely online event this year. The organizers of India Voice Fest will coordinate with all the final nominees to be present online during the

announcement of the final winners. We will make our best efforts to make the online awards presentation as exciting as possible :)
